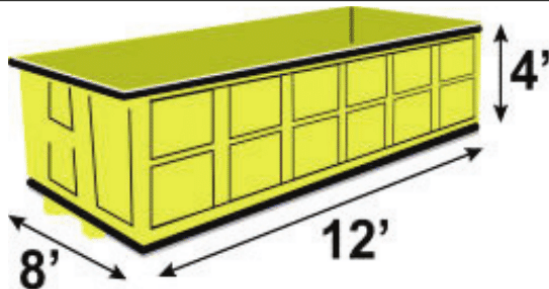

# Container Rental Agreement

## TERMS OF RENTAL

### WHEN IS PAYMENT DUE?

THE HAULING FEE WILL BE CHARGED AT TIME OF DELIVERY. A SECOND CHARGE OCCURS ONLY IF THE PICK UP DATE EXCEEDS THE TIME LIMIT ALLOWED, OR THE WEIGHT OF THE MATERIAL IN THE CONTAINER EXCEEDS THE ALLOWED WEIGHT LIMIT, OR THERE ARE SURCHARGABLE ITEMS LOADED IN THE CONTAINER (see list on front page).

### WHAT ISN'T ALLOWED IN THE CONTAINER?

HAZARDOUS MATERIALS INCLUDING CHEMICALS, GASOLINE, OILS, PAINTS, SOLVENTS, CAR BATTERIES, ASBESTOS OR ASBESTOS CONTAINING MATERIALS, PROPANE TANKS OR ANY TYPE OF TOXIC WASTE. CONCRETE, BRICK OR RUBBLE, NOT MORE THAN 10% OF THE ALLOWED WEIGHT OF THE CONTAINER.

### CAN I MOVE THE CONTAINER?

NO! ANY DAMAGE DONE WILL BE USERS RESPONSIBILITY. CALL FALCONE ROOFING, FOR A REASONABLE FEE, WE WILL MOVE THE CONTAINER.

### HOW HIGH CAN I LOAD THE CONTAINER?

PLEASE ONLY LOAD TO THE TOP OF THE WALL EDGE. IF OVERLOADING OCCURS, ADDITIONAL CHARGES WILL BE ASSESSED. IF UNSAFE, THE CONTAINER WILL BE UNLOADED TO A SAFE LEVEL.

### WHAT ITEMS HAVE A SURCHARGE?

AIR CONDITIONER, APPLIANCE, AUTO/TRUCK TIRE, MATTRESS/BOX SPRING, TELEVISION, COMPUTER MONITOR & WATER HEATER, ALL HAVE A LANDFILL SURCHARGE. PER ITEM ADDITIONAL RATES ARE LISTED ON FRONT PAGE.

### EXTRA DAYS:

THE STANDARD CONTAINER RENTAL TERM IS 7 DAYS. YOU MUST CALL IN YOUR RETURN PICK UP BY 6:00 PM ON THE SEVENTH DAY. IF NOT YOU WILL BE CHARGED AN EXTRA DAY AT THE RATE OF \$7.00 PER DAY

### DROP SITE DISCLAIMER:

CUSTOMER WARRANTS THAT ANY ACCESS/LOCATION PROVIDED FOR CONTRACTORS EQUIPMENT IS SUFFICIENT TO BEAR THE WEIGHT OF ALL EQUIPMENT AND VEHICLES REQUIRED TO PERFORM THE SERVICE. CONTRACTOR SHALL NOT BE RESPONSIBLE FOR DAMAGE TO ANY PRIVATE PAVEMENT OR ACCOMPANYING SUB-SURFACE OR ANY ROUTE REASONABLY NECESSARY TO PERFORM THE SERVICES HERIN CONTRACTED. IN ADDITION CONTRACTOR SHALL NOT BE RESPONSIBLE FOR DAMAGE TO LAWNS, FENCES, OR SHRUBBERY. CUSTOMER ASSUMES ALL LIABILITIES FOR DAMAGE TO PAVEMENT OR ROAD SERVICE, LAWNS, FENCES AND SHRUBBERY.
